

INTERDEPARTMENTAL PROJECT REVIEW MEETING APPLICATION

APPLICATION SUBMITTAL REQUIREMENTS

Interdepartmental Project Reviews are **mandatory** for new construction projects that propose buildings eight (8) stories or more and new construction on parcels identified by the State of California Department of Conservation, Division of Mines and Geology as Seismic Hazard Zones in the City and County of San Francisco. Projects identified as such, must request and participate in an interdepartmental project review prior to any application that requires a public hearing before the Planning Commission or new construction building permit.

Project Sponsors may elect to request an interdepartmental review for any project at any time, however, it is strongly recommended that the request is made prior to the submittal of the above referenced applications.

The Planning Department acts as the lead agency in collaboration with the Department of Building Inspection (DBI); San Francisco Public Works; and the San Francisco Fire Department (SFFD). A representative from each of these City Agencies will attend your meeting.

WHAT TO SUBMIT:

- 1. One (1) original of this application with all blanks filled in:
- One hard copy set of reduced sized (11"x17")
 plans, including but not limited to plans showing
 adjacent structures, existing and proposed floor
 plans, elevations, and sections;
- Planned unit developments or projects with an acre or more of land area shall be required to submit the existing and proposed street names and widths, location of any existing train tracks, and location of any existing and proposed easements;
- A digital copy of all documents submitted (CD or USB drive), containing this application, project drawings or plans; and
- 5. A credit card or check made payable to the "San Francisco Planning Department" for the required application fee (See Fee Schedule). Please note, all returned checks are subject to a \$50.00 bank fee.

Interdepartmental Project Reviews are scheduled no sooner than two weeks from the recipt of the request form and payment:
